- The Bidder must quote rate for supply of at least 10,000 pcs of each item per year.
- Items/Products/Samples shall be accepted only if the specification fixed by buyer of WBHDCL is met and sample is approved by the buyer. The specification is enclosed in Annexure-I.

### **Technical Evaluation**

- First the credential documents shall be taken up for scrutiny and the eligible bidders who meet the credentials shall be listed. Thereafter the samples of the bidders (only whose credentials are in order), shall be examined in conformity with the test report.
- The sample submitted by the bidder should not contain any mark/label of manufacturer or supplier anywhere on the body of sample.
- Financial bid of only those bidders shall be opened whose credentials are in order and sample along with test report is as per specification of the buyer enclosed in **Annexure-I**.
- The participating bidders who shall fail to submit samples/Test report within stipulated time frame shall be rejected.
- The participating bidders who shall fail to submit sample in conformity with the approved specifications of the buyer in all respect shall be rejected.
- The authority reserves the right to distribute the order among the qualified bidders (if willing) at lowest/accepted rate.
- Rate to be quoted only as per existing specification approved by the buyer.
- Quoted rate shall be valid for next three years (F.Y.- 2024-25, 2025-26 & 2026-27)
- Order shall be awarded for three subsequent years (F.Y.- 2024-25, 2025-26 & 2026-27) separately.
- Orders for subsequent years shall be awarded on the basis of previous year performance.
- All rates shall be excluding GST, but including all cost of packaging and delivery.

- If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation.
- West Bengal Handicrafts Development Corporation Ltd. shall ask for 3% Performance security on value of work order.
- Payment shall be made only after the successful delivery and acceptance by the buyer of MANJUSHA and on receipt of payment against the supply from the buyer of MANJUSHA.

- The Competent Authority shall make on field Inspection of such Manufacturing Units to ensure the plant and machinery, production capacity and production quality. The quantity to be awarded shall be solely dependent on the production capacity and production quality as per the specification mentioned in **Annexure I**.
- However the awarded units shall be asked to submit 3% Performance Security on value of work order.
- Such willing MSE Garments manufacturing units of West Bengal can apply once the actual order is received by this corporation in prescribed format mentioned in **Annexure-II**.
