Terms and conditions

- c) Financial bid of only those bidders shall be opened whose credentials are in order.
- d) **The authority reserves the right to distribute the order among the qualified bidders (if willing to supply at lowest/accepted rate).**
- e) Rates quoted shall be excluding GST, but including all cost of packaging and delivery.
- f) Rate to be quoted only as per existing specification approved by the buyer.
- g) Rates quoted in the bid are to remain valid for a period of **36 months** or any other extension thereof made by the authority after the last date for bid submission as specified in this e-NIT. Bids valid for a shorter period shall be rejected as non-responsive.
- h) If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation. An affidavit has to be supplied in this regard at the time of receiving supply order.
- i) West Bengal Handicrafts Development Corporation Limited shall ask for Performance Guarantee on value of work order as per Government rule.
- j) **Payment shall be made only after the successful delivery and acceptance of supply and on receipt of payment from the buyer of MANJUSHA.**

In the event of e-filing, intending bidder may download the tender document from the website directly with the help of Digital Signature Certificate.

Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the website <https://wbtenders.gov.in>.
