Electronic-tender is hereby invited from the bonafide enlisted Manufacturers/ Suppliers/ Agencies/ Firms/ Individuals/ SHG/ Co- operative for supply of Apron set.

- **This e-tender is being invited to enable West Bengal Handicrafts Development Corporation Ltd. (MANJUSHA) to quote rates to different authorities who shall require the items.**
- **The exact value and quantity of supply can only be ascertained when actual order is received by West Bengal Handicrafts Development Corporation Ltd. (MANJUSHA) from the buyer.**

Terms and conditions

- a) Items/Products shall be accepted only if the specification and terms and condition fixed by buyer is met and sample is approved by buyer.
- b) Sealed sample embossed with PM-POSHAN (Mid-Day-Meal) logo & concerned District logo (Blank) should be submitted at Manjusha Head office within stipulated time.
- c) Cost of embossing logo shall be included in the rate offered in the BOQ by the bidder.
- d) First the credential documents shall be taken up for scrutiny and the eligible bidders who meet the credentials shall be listed. Thereafter the samples of the bidders only whose credentials are in order shall be examined.
- e) Thereafter all the samples shall be sent to the buyer for their approval. The choice of the buyer shall be final and binding.
- f) The sample submitted by the bidder should not contain any mark/label of manufacturer or supplier anywhere on the body of sample.
- g) One bidder is allowed to submit only one variety of samples for each item.
- h) Financial bid of only those bidders shall be opened whose credentials are in order.
- i) The authority reserves the right to distribute the order among the qualified bidders (if willing to supply at lowest/accepted rate).
- j) The rates quoted by the Bidder shall be deemed to include cost of embossing logo, packing, carrying and delivery and installation up to all locations and in such batches as per delivery programmer to be fixed from time to time. The rate quoted shall be exclusive of applicable GST.
- k) Rates quoted in the bid are to remain valid for a period of **36 months** or any other extension thereof made by the authority after the last date for bid submission as specified in this e-NIT. Bids valid for a shorter period shall be rejected as non-responsive.
- l) If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation. An affidavit has to be supplied in this regard at the time of receiving supply order.
- m) West Bengal Handicrafts Development Corporation Limited shall ask for Performance Guarantee on value of work order as per Government rule.
- n) Payment shall be made only after the successful delivery and acceptance of supply and on receipt of payment from the buyer of MANJUSHA.

In the event of e-filing, intending bidder may download the tender document from the website directly with the help of Digital Signature Certificate.

Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the website <https://wbenders.gov.in>. Tender document may be downloaded from website & submission of Technical Bid/Financial Bid as per Tender time Schedule stated. The documents submitted by the bidders should be properly indexed & digitally signed.
