**Notice inviting period e-tender No. WBHDCL/NIT-405/2022-23 Dated:01/12/2022
of the West Bengal Handicrafts Development Corporation Limited (MANJUSHA)**

Short electronic-tender is hereby invited from the Bonafide Manufacturers/ Suppliers/ Agencies/ Firms/ Individuals/ SHG/ Co- operative for supply of **approximately One Lakh Pieces of Acrylic Woollen Sweaters for age group 10 to 14 years, front open with button, unisex as per approved sample of different colours.**

- **Quantity put to tender: 1,00,000 Pcs (One lakh pieces), Size: 32, 34, 36 & 38.**
- **The supply should be completed within 30 days of issuing of work order due to very short delivery period.**
- **EMD Rs. 25,000.00/- (Rupees Twenty Five Thousand only) refundable is to be deposited either online by Net Banking through using ICICI Bank Payment Gateway or through RTGS/NEFT. Please refer memo no. 3975-F(Y) dated 28.07.2016 of the Finance Department, Govt. of West Bengal.**
- **EMD exemption for registered SSI Units of the state of West Bengal shall be guided by paragraph 47A (1) of Memo No. 10500-F dated: 19.11.2004, issued by the Finance Department (Audit Branch), Government of West Bengal.**
- **It may be noted that the state government will provide a price preference of 15% to State based MSE [Micro and Small Enterprises] in conformity with Finance Department Notification No. 6142-F(Y) dated 10.10.2017. The Price preference clause implies that if an MSE unit has quoted upto 15% higher than the L1 rate, then that MSE unit can be considered preferentially for placements of orders provided he agrees to supply at the L1 rate discovered in this tender process.**

Terms and conditions

- a) Items/Products/Samples shall be accepted only if the specification fixed is met and sample is approved.
- b) First the credential documents shall be taken up for scrutiny and the eligible bidders who meet the credentials shall be listed. Thereafter the samples of the bidders only whose credentials are in order shall be examined.
- c) The sample submitted by the bidder should not contain any mark/label of manufacturer or supplier anywhere on the body of sample.
- d) Financial bid of only those bidders shall be opened whose credentials are in order and sample shall be as per approved specification of the buyer.
- e) The participating bidders who shall fail to submit samples within stipulated time frame shall be rejected.
- f) The participating bidders who shall fail to submit sample in conformity with the approved specifications of the buyer in all respect shall be rejected.
- g) The authority reserves the right to distribute the order among the qualified bidders (if willing) at lowest/accepted rate considering the short time of supply.
- h) Sizes of the sweater shall be strictly according to the standard of the industry.
- i) The rates quoted by the Bidder shall be deemed to include cost of packing, carrying and delivery up to all locations and in such batches as per delivery programme to be fixed from time to time. The rate quoted shall be inclusive of applicable GST. Apart from the rates in the Financial Bid, nothing extra or additional, shall be payable.
- j) Rates quoted in the bid are to remain valid for a period of 12 months or any other extension thereof made by the authority after the last date for bid submission as specified in this e-NIT. Bids valid for a shorter period shall be rejected as non-responsive.
- k) If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation. An affidavit has to be supplied in this regard at the time of receiving supply order.
- l) West Bengal Handicrafts Development Corporation Limited shall ask for Performance Guarantee on value of work order as per Government rule.
- m) Payment shall be made only after the successful delivery and acceptance of acrylic woollen sweaters and on receipt of payment from Government.

In the event of e-filing, intending bidder may download the tender document from the website directly with the help of Digital Signature Certificate.

Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the website <https://wbtenders.gov.in>. Tender document may be downloaded from website & submission of Technical Bid/Financial Bid as per Tender time Schedule stated. The documents submitted by the bidders should be properly indexed & digitally signed.
