Electronic-tender is hereby invited by the office of West Bengal Handicrafts Development Corporation Limited (MANJUSHA), IB-181, Sector-III, Salt Lake, Kolkata -700106 from the enlisted manufacturers or their distributors (authorization of manufacturer to be submitted) for supply of Woollen Blanket (as per enclosed Annexure-A).

- EMD exemption for registered SSI Units of the state of West Bengal shall be guided by paragraph 47A (1) of Memo No. 10500-F dated: 19.11.2004, issued by the Finance Department (Audit Branch), Government of West Bengal.

Terms & Conditions:

- Items/Products/Samples shall be accepted only if the specification fixed by buyer of WBHDCL is met. The specification is enclosed in Annexure-A.
- First the samples of the bidders shall be examined in conformity with the test report.
- The sample submitted by the bidder should not contain any mark/label of manufacturer or supplier anywhere on the body of sample.
- One bidder is allowed to submit only one variety of samples for each item.
- Thereafter the credential documents shall be taken up for scrutiny and the eligible bidders who meet the credentials shall be listed.
- Financial bid of only those bidders shall be opened whose credentials are in order and sample approved by the buyer.
- The participating bidders who shall fail to submit samples/Test report within stipulated time frame shall be rejected.
- The participating bidders who shall fail to submit sample in conformity with the approved specifications of the buyer in all respect shall be rejected.
- The authority reserves the right to distribute the order among the qualified bidders (if willing) at lowest/accepted rate considering the short time of supply on the basis of the capacity of the bidder on submitting in writing.
- Rate to be quoted only as per specification mentioned in Annexure-A approved by the buyer.
- Quoted rate shall be valid for **12 Months** or any extension thereof made by the authority.
- All rates shall be excluding GST but including all cost of packaging and delivery.

- If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation.
- West Bengal Handicrafts Development Corporation Ltd. shall ask for 3% Performance Security in the form of Bank Guarantee on value of the total order from the successful bidders.
- **Payment shall be made only after the successful delivery and acceptance by the buyer of MANJUSHA and on receipt of payment from them.**

In the event of e-filing, intending bidder may download the tender document from the website directly with the help of Digital Signature Certificate.

Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the website <https://wbtenders.gov.in>. Tender document may be downloaded from website & submission of Technical Bid/Financial Bid as per Tender time Schedule stated. The documents submitted by the bidders should be properly indexed & digitally signed.
